### Permissions

The permission to reproduce ASCCP material, including the Guidelines algorithms, must be sought well before the expected publication date of your document (i.e., a minimum of 4-6 weeks). The written requests should contain the following information:

1. Precise citation of the sought document or selection.
2. Title and publisher of your publication.
3. Means by which your publication will be distributed (i.e., included in a book, as a part of your patient education packet, handouts to students, on a CD, etc.).
4. Number of copies.
5. If tables, graphs, images, or algorithms are sought, you must include a copy of the material to be used.

Permissions are typically granted to reproduce selections of current ASCCP materials based on the following conditions:

1. Full credit to the source is shown as indicated in the permission granting letter.
2. The information must be reproduced without modification, with the exception of style and format changes. No edits (including changes to style and format) are allowed to the 2001 and 2006 Consensus Guidelines Algorithms.
3. Permission is given for one-time use and does not extend to electronic rights, subsequent editions, or foreign translations. Permission does not grant any third party reprint rights.

4. Permission is usually contingent on payment of a fee of \$100.00 per article selection. For the Guidelines Algorithms, the fee structure is based upon use (e.g., educational versus commercial).

Permissions are not granted to reproduce ASCCP material in any of the following circumstances:

1. Use of all or most of a publication (i.e., an entire Patient Education Pamphlet, one chapter from a book, or a form)
2. Electronic reproduction of material in any form. Note: Specific permission to link electronically to the Algorithms may be requested.
3. Use of material that is not original with ASCCP (the original publisher must be contacted).
4. Reproduction of a document that has been withdrawn from circulation.

## Reporting Copyright Infringements

The Digital Millennium Copyright Act, signed into law on October 28, 1998, amended the copyright law to provide limitations for service provider liability relating to material online. New subsection 512(c) of the copyright law provides limitations on service provider liability with respect to information residing, at direction of a user, on a system or network that the service provider controls or operates, if the service provider has designated an agent for notification of claimed infringement by providing contact information to the Copyright Office and through the service provider's publicly accessible website. 17 U.S.C. 512(c).

Elements of notification:

- A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
- Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site is covered by a single notification, a representative list of such works at that site.
- Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information, reasonably sufficient to permit ASCCP to locate the material.
- Information reasonably sufficient to permit ASCCP to contact you, such as an address, telephone number, and, if available, an electronic mail address at which you may be contacted.
- A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
- A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
